

This Contest is intended for viewing and participation in the United States only and shall be evaluated and construed in accordance with the laws of the United States. This Contest is restricted to entrants who are legal residents of and reside in the United States and District of Columbia and who are 18 years of age or older at the time of entering the Contest.

“FORCE FX COMBAT TRIALS” CONTEST OFFICIAL RULES

There are two ways to enter the “Force FX Combat Trials” Contest:

1. Send a self-produced (maximum 2-minute in length) video tape or DVD to be received by April 16, 2007 along with your completed registration form (one form per individual OR team) to: Master Replicas “Force FX Combat Trials” Contest, 201 North Civic Drive, Suite 239 Walnut Creek, CA 94596. Tapes or DVD’s received after April 16, 2007 will not be eligible for judging. Both the video submission AND the registration form must be received for you to be eligible to be selected for the contest.
2. Upload your self-produced (maximum 2-minute in length) video to the following YouTube address – <http://www.youtube.com/group/combattrials> – and either e-mail your completed registration form to combattrials@masterreplicas.com or fax it to 925-930-9198. Videos uploaded after April 16, 2007 will not be eligible for judging. Both the video submission AND the registration form must be received for you to be eligible to be selected for the contest.

The Master Replicas council will notify the contestant(s) as to whether they have been accepted into the trial by May 1, 2007. The contest will take place on both Saturday and Sunday, May 25th and 26th at Celebration IV in Los Angeles. When entrants are notified on May 1, they will be given the specific time(s) and date(s) of their performance – please note, entrants must plan on attending Celebration IV for both days (5/25 and 5/26) in order to be considered for entry.

This is not a Sweepstakes, no mass-produced or multiple entries allowed. Multiple entries will invalidate all entries. Limit one (1) entry per person, e-mail address or household address only. No purchase necessary to enter. There will be three separate competitions, and you may enter any one, two or all three, please see rules and regulations for each, to determine your eligibility:

FORCE FX BATTLE EXTREME:

The first trial is designed to show the dueling skills of the competitors (or team(s) of competitors). The competition is to be entered upon by a team of two or more, with a pre-choreographed Force FX lightsaber duel. This controlled dueling demonstration will show not only the skill of the contestants, but also their discipline in learning their routine and their ability to cooperate with their fellow aspiring Jedi Knights or Sith Lords.

Entrants for the *Force FX Combat Demonstration* must submit to the following rules and regulations:

This audition video must exhibit: (1) Technical competence with a Force FX Lightsaber, by all team members (2) The ability to safely use their Force FX Lightsaber, by all team members (3) A routine which is representative of the routine to be performed at the show. (Master Replicas reserves the right to stop and/or interrupt any routine at the show, which either differs drastically from the submission video, or is deemed unsafe by a Master Replicas representative.)

The demonstration must be at least one (1) minute long, and is not to exceed four (4) minutes in total length. The demonstration must include a minimum of two combatants, but there is no limit to the number of contestants &/or Apprentices who may participate. The demonstration must be restricted to a 15x20 foot floor-space. The submission video must take this limited space into account. The entrants must use unaltered Master Replicas Force FX Lightsabers

in their demonstration. Unauthorized lightsabers will result in immediate disqualification.

It is not required that a demonstration be set to music; however it is recommended, for dramatic effect. Likewise, costumes are not mandatory, but are recommended. Remember the judges will be voting based on your *entire* performance! No clothing bearing trademarked logos will be permitted for the submission video, or the competition.

All of the routines selected for the Demonstration will be voted upon by a pre-determined Council of judges – including Master Replicas staff members, and special guests (TBD). Contestants will be judged based on the following criteria: 1/3 Originality/Creativity; 1/3 Technique/Form and 1/3 Presentation/Entertainment Value.

Each of the three above criteria will be rated on a scale from 1-5 – 1 being the lowest, and 5 being the highest – by each judge. The judges' individual scores will then be added up, to give a score from 3-15, which each judge will display for the competitors on a card. For the cumulative score, all three judges' scores will be added together and averaged for the competitors FINAL score!

The Individual or Team who perform the winning routine will be awarded a trophy, a \$500 gift certificate for use at www.MasterReplicas.com and the title of Jedi Knight.

FORCE FX MASTER EXHIBITION:

The Force FX Master Exhibition is designed for master swordsmen (or swordswomen) to show off their stuff, either as individuals, or as a synchronized team! The competition is to be entered upon by individuals or teams of two or more, with a pre-choreographed Force FX lightsaber exhibition – highlight your finesse without fighting! This controlled, civilized demonstration – think of it like synchronized swimming or ice skating, but with sabers! – will demonstrate not only the skill of the Padwans, but their discipline, their grace, and their flare for the dynamic and dramatic!

Entrants for the *Force FX Master Exhibition* must submit to the following rules and regulations:

The audition video must exhibit (1) Technical competence with a Force FX Lightsaber, by all team members; (2) The ability to safely use their Force FX Lightsaber, by all team members; (3) A routine which is representative of the routine to be performed at the show. (Master Replicas reserves the right to stop and/or interrupt any routine at the show, which either differs drastically from the submission video, or is deemed unsafe by a Master Replicas representative.) The demonstration video must be at least one (1) minute long, and is not to exceed three (3) minutes in total length. The demonstration must include a minimum of one contestant, but there is no limit to the number of contestants who may participate. The demonstration must be restricted to a 15x20 foot floor-space. The submission video must take this limited space into account.

The entrants must use unaltered Master Replicas Force FX Lightsabers in their demonstration. Unauthorized lightsabers will result in immediate disqualification.

It is not required that a demonstration be set to music; however it is recommended, for dramatic effect. Likewise, costumes are not mandatory, but are recommended. Remember the judges will be voting based on your *entire* performance! (No clothing bearing trademarked logos will be permitted for the submission video, or the competition.)

Should entrants be admitted into the competition, they will be responsible for providing their own musical selections in CD format, as well as their own Force FX Lightsabers and costumes.

All of the routines selected for the Demonstration will be voted upon by a pre-determined Council of judges – including Master Replicas staff members, and special guests (TBD). Contestants will be judged based on the following criteria: 1/3 Originality/Creativity; 1/3 Technique/Form; and 1/3 Presentation/Entertainment Value.

Each of the three above criteria will be rated on a scale from 1-5 – 1 being the lowest, and 5 being the highest – by each judge. The judges' individual scores will then be added up, to give a score from 3-15, which each judge will display for the competitors on a card. For the cumulative score, all three judges' scores will be added together and averaged

for the competitors FINAL score!

The Individual or Team who perform the winning routine will be awarded a trophy, a \$500 gift certificate for use at www.MasterReplicas.com and the title of Jedi Knight.

FORCE FX FREESTYLE CHALLENGE:

For this trial, our competitors will be randomly inserted into a traditional bracket. Each will be pitted against another competitor in a Freestyle Lightsaber battle. The first combatant (Competitor A) will have 30 seconds to show his or her stuff, while their opponent watches. (There is to be no contact between sabers during this competition!) Then the second combatant (Competitor B) will have 30 seconds to rebut. Then Competitor A has 30 seconds, and finally Competitor B once again. For this event, the music will be provided by the Council.

Entrants for the *Force FX Combat Demonstration* must submit to the following rules and regulations:

This audition video must exhibit: Technical competence with a Force FX Lightsaber and the ability to safely use their Force FX Lightsaber. The competition will be restricted to a 15x20 foot floor-space

The entrants must use unaltered Master Replicas Force FX Lightsabers in their demonstration. Unauthorized lightsabers will result in immediate disqualification.

It is required that a demonstration be set to music; however, the music will be provided by the Council from a randomly selected pre-recorded source. Judging for this particular event will be based upon crowd reaction, which will be decided upon by a Master Replicas council member.

The Winning contestant will be awarded a trophy, a \$500 gift certificate for use at www.MasterReplicas.com and the title of Jedi Knight.

GENERAL:

All entrants admitted into the competition will be responsible for providing their own musical selections in CD format, as well as their own Force FX Lightsabers and costumes. Entrants accepted into the competition are also responsible for providing all expenses including, but not limited to: Transportation to and from the event venue (Los Angeles Convention Center, May 26 & 27). Accommodations throughout the length of the competition and All fees associated with entry to the show venue. Those selected to participate in the Force FX Combat trials will be notified by the Council at Master Replicas on or before May 1, 2006. This will allow competitors three weeks to put the finishing touches on their routines, and to prepare for the trials ahead. At the time that competitors are notified of their acceptance, they will also be given a schedule of events for the show. Competitors MUST be at the Master Replicas booth ½ an hour before the designated time of their trial.

The contestant who makes it to the final round and emerges triumphant will receive a trophy and the title of Jedi Knight.

All entries become the property of Sponsor and will not be returned.
